The Robitaille Endowment Fund:

The Robitaille Endowment Fund was established to provide financial support to CAVR member affiliate associations and CAVR members to assist them by providing training sessions, seminars or workshops related to volunteer management. These educational opportunities can be provided through a local, regional, or provincial forum and MUST contain a CAVR component that addresses CAVR standards of practice, membership, certification, and/or the employment resources.

Applications for a grant, not exceeding \$200, may be submitted once per fiscal year (April 1 to March 31) by:

- President of affiliate association (e.g. AVRBC, MAVA, PAVR-O)
- CAVR members whose membership is through their affiliate association
- Individual CAVR members not related to an affiliate association

Membership

CAVR is the only national chartered association whose mandate is to support Administrators of volunteer resources.

- Educational opportunities through national/provincial/regional conferences and access to participation in national long-distance education sessions.
- Quarterly receipt of the Canadian Journal of Volunteer Resource Management (CJVRM) where members publish and share articles on current trends in the profession.
- A nationally recognized Code of Ethics and Standards of Practice.
- Frequent Association updates and e-newsletters keeping all members informed on Association news and developments across Canada.
- Networking opportunities with colleagues working in similar programs and agencies to share ideas and information.
- Representation at a national forum and round table discussions on national issues affecting Volunteerism.
- Participation in policy design, social action and position paper development through a strong national voice for the profession.
- Strategic alliances with other provincial, national and international associations

Membership Fees and Procedure

The CAVR Membership year is from April 1 - March 31. If you obtain membership through an affiliate with a different membership year, your membership with CAVR will follow your affiliate association's membership year.

- Individual Member \$70.00 (Canadian)
- Affilitate Member (Must be registered through one of CAVR's Affiliate Groups)
 \$35.00 (Canadian)

Individual membership fees are due on April 1 of each year. Individual members joining CAVR between October 1 and December 31 will receive their membership at half price for the remaining portion of that membership year. Individual members joining CAVR on or after January 1 will pay the full membership amount but will have their membership extended to March 31 of the following membership year.

What is Advocacy?

By definition it is:

- Active support of a cause
- Public support for or recommendation of a particular cause or policy
- The act of pleading or arguing in favor of something, such as a cause, idea, or policy

An Advocate is someone who:

- Speaks or writes in favor of a cause
- Recommends the cause publicly

You are an Advocate for our profession every day!

Being proud of your position within your organization and doing it well is a form of Advocacy.

The way in which you conduct yourself at meetings, your level of professionalism and the knowledge you bring to the table is actively supporting our profession.

Remember that people pay attention to your actions, so make them count!

As professionals we want to ensure that others understand what we do. Sometimes it is not always clear to those who don't work in the field of Volunteer Management.

Take a minute to look at the online presentation for the National Occupational Standards (NOS) on the CAVR website. You can customize it to suit your organization.

The next time a colleague asks you "What exactly do you do?" take the opportunity to ask to be invited to the next Management Meeting, to present the NOS and how this standard can benefit the organization.
