ANNUAL REPORT OF THE PRESIDENT

I would like to thank the CAVR Executive, Board Members and Committee Members. **Objectives established for the Year:**

Results / Outcomes:

2008/2009 has been a very satisfying year in my role as President. We have connected with international group-Global Volunteer Program Managers: n international community that can help develop the global movement of volunteer management, leadership and administration. We have created a unique partnership for our 2009 conference joining two national organizations and their affiliates-highlighting the value of partnerships and relationships.

We have been exploring new affiliate opportunities across the country as we strive to further connect our national efforts to provincial and local groups. We are thrilled that NLAVR has once again offered to host a CAVR conference for 2010- and have no doubt it will exceed the success of the last program in 2006! We continue to work closely with Volunteer Canada as we move forward with our goals for excellence in volunteer administration and many of our Board represent the CAVR perspective on national provincial and local Boards across Canada

New Initiatives / Directions Taken:

ANNUAL REPORT OF THE PAST PRESIDENT

Between January 2007 and May 2009, the HR Council for the Voluntary and Non-profit Sector has conducted a comprehensive Sector Study in order to develop a national human resource strategy for the sector. The Study was intended to address gaps in information about the key characteristics of the sector's labour force and to address the issues of skill needs and recruitment and retention. CAVR joined a network of stakeholders from across the country to guide the Sector Study and has been actively involved throughout the past two years.

The findings of the surveys of employers and employees can be found at www.hrcouncil.ca. Recommendations based on the findings will be posted in June, 2009. This is a significant step forward for the voluntary sector, as it will present findings from research on recruitment and retention challenges; identification of current and emerging skill needs; and recommendations for follow-up action leading to a human resources strategy for the voluntary/non-profit sector in Canada. CAVR members were represented during this study phase and will continue to be involved as the strategy unfolds.

The Constitution and By-laws of CAVR have been updated and placed on the website for all members to access. The most recent version will be filed with Industry Canada this year. The Policy and Procedures manual is also in need of an update and the review process will be undertaken in the coming year.

Through the newsletter Exchange, as well as the website, members have been kept up to date on topics such as: Volunteer Management Software, Integrating Skilled Volunteers and regular updates on the work of the HR Council.

I would like to acknowledge and thank the CAVR Executive for the Vice-President Advocacy committee: Cheri Galloway-Reuben, Chris Peacock, Charlene Dishaw and Barb Gemmell

Objectives established for the Year:

As VP and outgoing Advocacy Chair, my objectives for the year were to mentor the new Advocacy Chair and to work with the CAVR Executive on the following:

- On-going assessment, development and updating of the website
- New job descriptions for some board positions (Membership Chair, Secretary, 2nd Vice-President)
- Begin a review of the Policies and Procedures Manual
- Review the process of orienting new Board members and handing over responsibilities
- Contact Montreal/Quebec organizations about the possibility of holding a CAVR conference in Montreal in 2010

Unfortunately, it has not been possible to work on the Advocacy Committee objectives of improving the existing tools, developing new ways of using them and translating them into French.

Results / Outcomes:

- Two teleconferences were offered after the Hamilton conference to give members an overview of the CAVR workshops
- One presentation was made to a local VMG in Ontario (Advocacy tools)
- In discussion with the Executive, the decision was made to create a new position on the board dedicated to the website
- Hosted a discussion amongst the Volunteer Bureau of Montreal, two CAVR affiliate groups in Québec and the local network, RABQ (Réseau de l'action bénévole du Québec) about the possibility of hosting a CAVR conference. While the immediate response is "no", the interest is there. The discussion prompted a reflection on our collective lack of experience in Quebec and the pertinence of organizing a provincial event which would help us to develop that experience as well as our working relationships.
- Two articles were provided for Exchange

New Initiatives / Directions Taken:

- Advocacy committee members were contacted to gage their interest in continuing in 2009-2010
- The Advocacy presentation for the conference in Edmonton was adapted for the new format of short, interactive conversations with small groups as they make their way from one table to another in a "speed dating" mode

Recommendations for Next Year:

- Phase out the 2nd Vice-President position
- Encourage all board members to include advocacy as part of their role, whether

- or not there is a functioning Advocacy Committee
- Support incoming board members as much as possible to ensure they feel comfortable, included and effective

In conclusion, I would like to express my appreciation for the members of the Executive Committee and the Board. It has been a pleasure to experience your good nature, graces and professionalism during this year of multiple transitions and challenges.
